BOARD MEETING AGENDA

1. Roll call/sign in

Trustees Sona Karia (The Chair), Latoya Massey (The Treasurer) Ramon Perdomo (The Secretary), Tavannie Perez and Jared McShall were present, constituting a quorum. The meeting was conducted via Zoom video-conference, pursuant to the Governor's emergency regulations, at a virtual location open to the public, and designated on the Notice of Meeting.

2. Filing of Notice of Meeting

In accordance with the law, a notice of the meeting was published on the school's website, sent via email to the New York Times and posted publicly on the Innovation High School Website.

4. North Star Data Team (15 minutes, Prog. Mgr. Student Affairs & Data Accountability, Principal, ED, Manager, Operations & HR)

a. Enrollment Update

Ms. Emily Bierwerth reported on that we ended semester 1 at 404 students with a actual number of 401 by 2/8/2023. There have been students that begin the application process for a GED program that don't follow through which effects our numbers. Other factors effecting students moving out of our organization included their families moving, as well as some students seeking services Innovation High School does not have the capacity to provide. We have enrolled 5 new students for the start of semester 2. We are currently using the enrollment tool SchoolMint to field applications. Mr. Falla Riff stated that the goal is to return to the enrollment number of 405. Ms. Tavannie Perez asks what specific reasons led to the 13 students in question leaving. Ms. Bierwerth responded that there were a variety of reasons including, safety, travel time, to simply preferring their previous environment.

b. Credit Accumulation

After marking period 2, there were 201 students considered on track for graduation. As of the end of semester 1, we now have 280 students considered on track to graduate, highlighting efforts by the schools family engagement team. 78% of third year students are on track to graduate this year representing a 17% increase compared to last years 3rd year cohort (61%)

Ms. Abdul-Majid stated that she has left a record of questions in the chat that can be addressed at a later time, but wanted to acknowledge the serious crisis in Turkey stemming from the earthquake that just occurred and asked us to keep those affected by this in our hearts.
